#### Be an Active Part of Your Credit Union

Any member desiring to run for the Board of Directors during the March 2019 Annual Meeting, must contact the credit union to pick up the required forms. Applications to run for the Board will be available to interested members at the credit union's office located at 1120 N Tancahua in Corpus Christi, Texas. After completing the required forms, you must also include a brief statement of qualifications with biographical data and return to the credit union in order to be considered and/or selected by the Nominating Committee. Please be informed that nominations for vacancies can also be made by petition signed by 1% of the membership with a minimum of 20 signatures. Each nominee by petition must also submit a brief statement of qualifications and include biographical data (this can be a director application) 30 days out from the Annual Meeting the names by petition will be posted in a conspicuous place at the Credit

Union. There will be one (2) positions up for election, carrying a three (3) year term. In order to qualify for a position of a Board of Director for the Corpus Christi Southern Pacific Credit Union, the member must be:

- 1. Age 18 or older and
- 2. Must be a member of a good standing. (A member with paid up membership currently in effect, and not in default upon any obligations owed the credit union and/or any other creditor as reflected in a credit report obtained from any credit reporting agency, and not having ever been convicted of a felony.)
