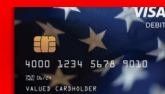

Access to Credit Union Documents

The Texas Administration Code, Title 7, Part 6, Chapter 91, Subchapter C, Rule 91.315 Members' Access to Credit Union Documents, provides the membership access to certain credit union documents. The purpose of this policy is to ensure that Corpus Christi S.P. Credit Union (CCSPCU) complies with adherence to all mandated state and federal credit union regulations.

The Texas Administrative Code requires:

Upon written request, our members are entitled to review or receive a copy of the version of the following credit union documents:

- 1) Balance Sheet and Income Statement (the non confidential pages of the latest call report may be given to meet this requirement:
- 2) A summary of the most recent annual audit
- 3) A written board policy regarding access to the articles of incorporation, bylaws, rules, guidelines, board policies and copies thereof, and
- 4) Internal Revenue Service Form 990

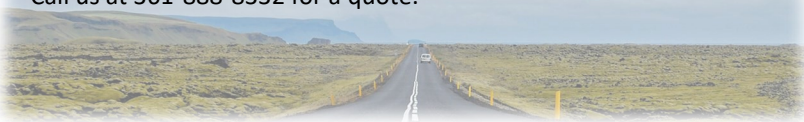

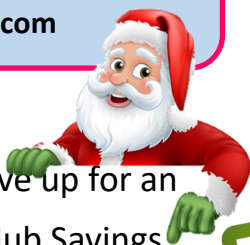
